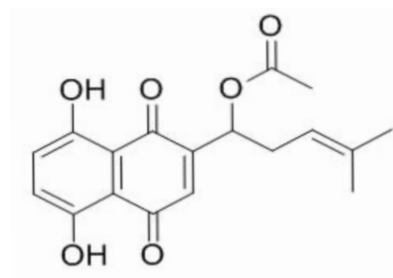

Shikonin, acetylshikonin, and isobutyrylshikonin inhibit vascular endothelial growth factor (VEGF)-induced angiogenesis and suppress tumor growth in lewis lung carcinoma-bearing mice, they exhibit the antiangiogenic and antitumorigenic effects by

Acetylshikonin inhibits the generation of NADPH oxidase complex in the activation of respiratory burst of PMNs, but does not directly inhibit the activity of NADPH oxidase suppressing proliferation and angiogenic factors.

Acetylshikonin a novel AChE inhibitor, can inhibit apoptosis via upregulation of heme

Acetylshikonin, one naphthoquinone pigment from *Lithospermum erythrorhizon*, it suppresses adipocyte differentiation in a dose-dependent manner and significantly attenuated adipogenic transcription factor expression in 3T3-L1 cells, suggests that *Lithospermum erythrorhizon* prevents obesity by inhibiting adipogenesis through downregulation of genes involved in the adipogenesis pathway and may be a useful

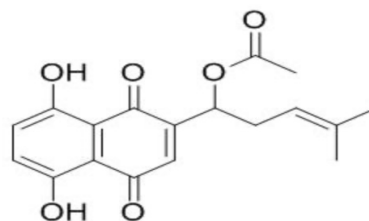
