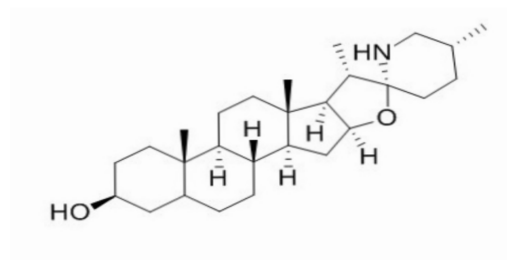

[1] Tomatidine and lycotetraose, hydrolysis products of alpha-tomatine by *Fusarium*
ApoE-deficient mice by inhibiting Acyl-CoA:cholesterol Acyl-transferase (ACAT).

Tomatidine can inhibit replication of *Staphylococcus aureus* small-colony variants in cystic fibrosis airway epithelial cells, it eventually will find some use in combination therapy

Tomatidine can inhibit invasion of human lung adenocarcinoma cell A549 by reducing matrix metalloproteinases expression, it also inhibits ERK and Akt signaling pathways and NF- κ B activity, demonstrates that a new therapeutic potential for tomatidine in *oxysporum* tomatinase, suppress induced defense responses in tomato cells.

Tomatidine acts as an anti-inflammatory agent by blocking NF- κ B and JNK signaling, and may possibly be developed as a useful agent for the chemoprevention of cancer or

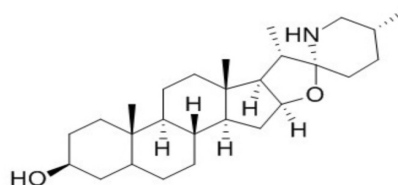
