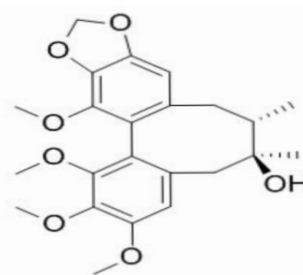

### BIOLOGICAL ACTIVITY OR INHIBITORS

Gomisin A(GA), a dibenzocyclooctadiene compound isolated from Schisandra chinensis, reverses multidrug resistance (MDR) in Pgp-overexpressing HepG2-DR cells; it is relatively non-toxic but without altering Pgp expression, it restores the cytotoxic actions of anticancer drugs such as vinblastine and doxorubicin that are Pgp substrates but may act by different mechanisms; suggests that gomisin A alters Pgp-substrate interaction but

Gomisin A improves hepatic cell degeneration, vasodilatory activity and insulin sensitivity. These effects also impact the immune system, including various inflammatory mediators and cytokines; the anti-inflammatory properties of GA potentially result from the inhibition of COX-2, iNOS, IL-6, TNF- $\alpha$  and NO through the down-regulation of RIP2 and NF- $\kappa$ B itself is neither a Pgp substrate nor competitive inhibitor.

Gomisin A has anti-apoptotic and hepatoprotective effects on fulminant hepatic failure activation.

Gomisin A protects the liver from injury after administration of acetaminophen through the induced by D-galactosamine and lipopolysaccharide in mice.

Gomisin A inhibits tumor promotion by 12-O-tetradecanoylphorbol-13-acetate in two-stage suppression of lipid peroxidation.

Gomisin A induces Ca<sup>2+</sup>-dependent activation and translocation of eNOS in HCAEC, carcinogenesis in mouse skin.

[6] Gomisin A has antihypertensive effect on angiotensin II-induced hypertension via events linked to NO production and thereby endothelial-dependent vasorelaxation.

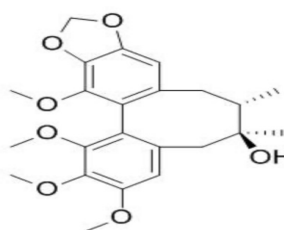
