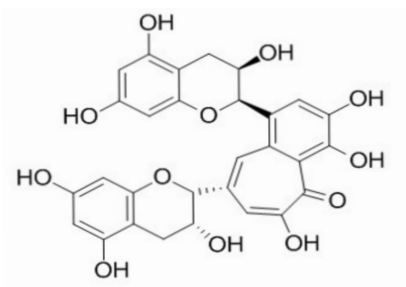

BIOLOGICAL ACTIVITY OR INHIBITORS

Theaflavin(TF) has antioxidant activity, the TF present in black tea possess at least the same antioxidant potency as catechins present in green tea, and that the conversion of catechins to TF during fermentation in making black tea does not alter significantly their

free radical-scavenging activity.

Theaflavin significantly reduces lipid accumulation, suppressed fatty acid synthesis, and stimulate fatty acid oxidation, also inhibits acetyl-coenzyme A carboxylase activities by stimulating AMP-activated protein kinase (AMPK) through the LKB1 and reactive oxygen species pathways; it is bioavailable both in vitro and in vivo and may be active in the

prevention of fatty liver and obesity.

Theaflavin induces G2/M arrest by modulating expression of p21 waf1/cip1 , cdc25C and cyclin B in human prostate carcinoma PC-3 cells, it acts as an effective anti-proliferative

Theaflavins from Black Tea, have inhibition of ultraviolet B and induces AP-1 agent by modulating cell growth regulators in prostate cancer cells.

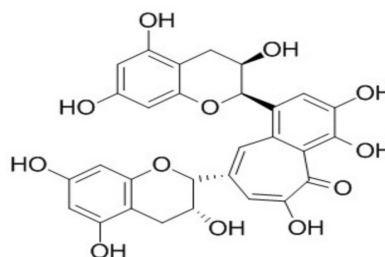
