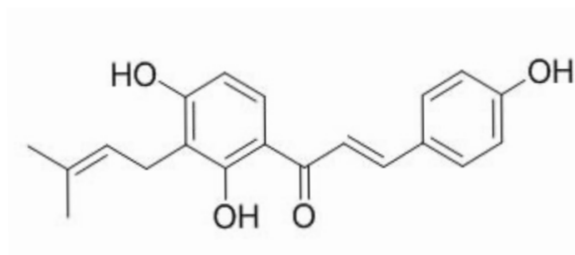

Isobavachalcone exhibits intrinsic antibacterial activity against several Gram-negative bacteria, and its activities are significantly improved in the presence of an efflux pump inhibitor (MIC values decreased to below 10 microg/ml), indicates that isobavachalcone could be candidates for the development of new drugs against multidrug-resistant (MDR)

strains and that its use in combination with efflux pump inhibitors reinforces its activity. Isobavachalcone may have suppressive effects against by melanin in the skin. Isobavachalcone can suppress inducible nitric oxide synthase (iNOS) expression induced by macrophage-activating lipopeptide 2-kDa, polyriboinosinic polyribocytidylic acid, or lipopolysaccharide; indicates the potential of isobavachalcone as a potent

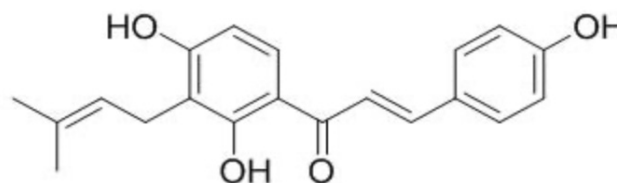
