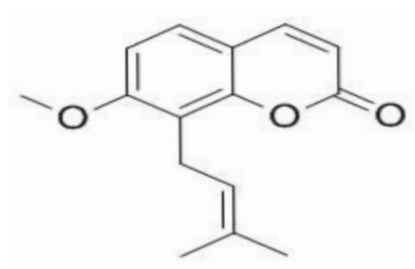

BIOLOGICAL ACTIVITY OR INHIBITORS

Osthol, one major component of *Cnidium monnieri* fructus, has anti-allergic effect.

Osthol can inhibit P-388 D1 cells in vivo and induce apoptosis in HeLa cells in vitro in a time- and concentration-dependent manner, and that osthol is good lead compound for developing antitumor drugs. [2]

Osthol induces a significant increase in acyl-CoA oxidase mRNA expression associated with an increase in carnitine palmitoyl transferase 1a mRNA expression, which suggests the acceleration of beta-oxidation of hepatic fatty acids, at least in part, for the reduction of hepatic triglyceride content in SHRSP; suggests that osthol could be useful for both

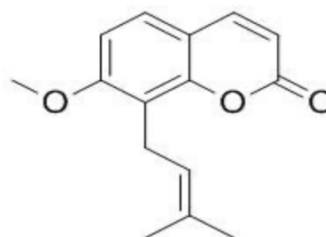
