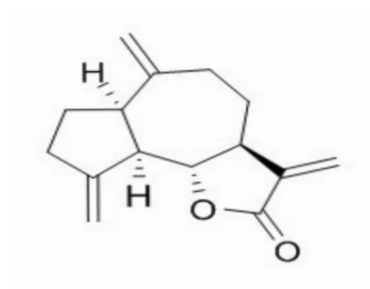

Dehydrocostus lactone(0.1-10microg/ml) can protect osteoblasts against H2O2-induced cellular dysfunction, may be valuable as a protective agent against oxidative damage in [2]

increasing the promoter activity of antioxidant response element (ARE).

Dehydrocostus lactone and costunolide exhibits strong larvicidal activity against *A. albopictus* with LC(50) values of 2.34 and 3.26 ug/ml, respectively, while the essential oil had an LC(50) value of 12.41 ug/ml.[4]

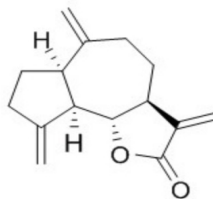
