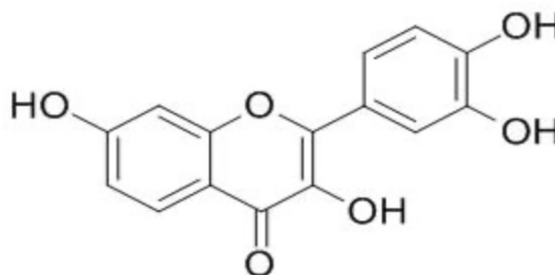

BIOLOGICAL ACTIVITY OR INHIBITORS

Fisetin inhibits TH2-type cytokine production by activated human basophils. Fisetin functions as a dual inhibitor of mTORC1/2 signaling leading to inhibition of prostate cancer (CaP)-dependent translation and induction of autophagic cell death in PC3 cells, suggests that fisetin could be a useful chemotherapeutic agent in treatment of hormone [2]

Fisetin has anti-inflammatory activity in human mast cells (HMC-1) through the down refractory CaP.

[3] Fisetin is an inhibitor of androgen receptor (AR) signaling axis, it could be a useful [4] suggests that fisetin has a potential protective effect against cataractogenesis. Fisetin has direct antioxidant activity, it can also increase the intracellular levels of glutathione (GSH), the major endogenous antioxidant, and fisetin has both neurotrophic -regulation of mast cell activation.

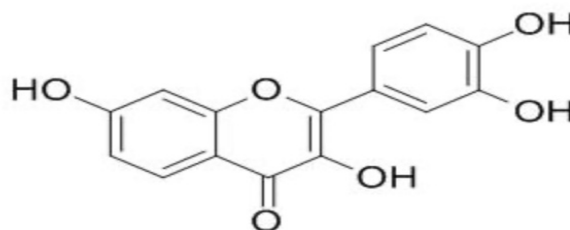
