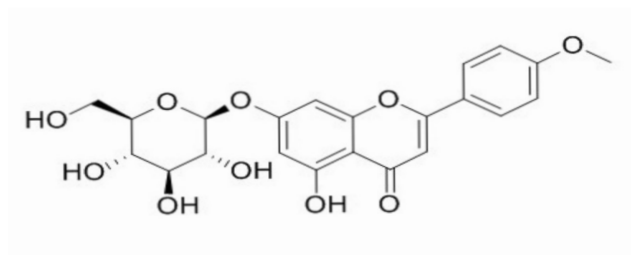

Tilianin, isolated from *Agastache mexicana*, is not toxic for rodents, it has antihypertensive [1]

iNOS expression and production of NO.

Tilianin has anti-atherogenic activity in hyperlipidemic mice, it ameliorates atherosclerosis by inhibiting the production of the NF-kappaB-dependent pro-inflammatory cytokines,

[3] profile, and increasing adiponectin expression.

Tilianin has cardioprotective effects, pretreatment with tilianin exerts potent cardioprotective effects in rats with myocardial ischemia/reperfusion injury(MI/RI), the antiMI/RI effects comprises relieving calcium overload, correction of energy metabolism,

[5] effect (ED50=53.51 mg/kg,LD50=6624 mg/kg ) in a dose-dependent manner.

Tilianin has anti-inflammatory activity, has inhibitory effects on the expression of inducible nitric oxide(NO) synthase in low density lipoprotein receptor deficiency mice, it inhibits

[2] TNF-alpha and IL-1beta, via the inhibition of IkappaB kinase activity.

Tilianin has antidiabetic and antihyperlipidemic effects, short-term tilianin treatment may exert its antidiabetic and antihyperlipidemic effect by modulating a pro-inflammatory

[4] improvement of endothelial function and inhibiting cell apoptosis.

Tilianin can inhibit the proliferation and migration of vascular smooth muscle cells(VSMCs) induced by TNF- $\alpha$ , which may be one of pharmacological mechanisms of tilianin in

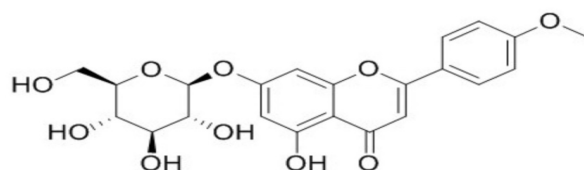
