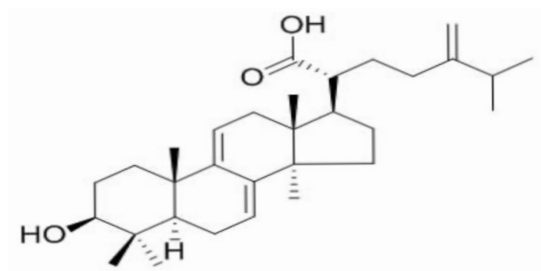

BIOLOGICAL ACTIVITY OR INHIBITORS

Dehydroeburicoic acid, isolated from the ethanolic extract of *Antrodia camphorata* (AC), has cytotoxicity, it activates DNA damage and apoptosis biomarkers similar to triterpenoid-rich fraction (FEA) and also inhibits topoisomerase II, its treatment resulted in a marked decrease of tumor weight and size without any significant decrease in mice [1]

Dehydroeburicoic acid and eburicoic acid have excellent anti-inflammatory activities and [2]

Dehydroeburicoic acid and eburicoic acid have hepatoprotective effects against CCl₄-induced hepatic damage via antioxidant and anti-inflammatory mechanisms, they can significantly decrease inducible nitric oxide synthase (iNOS) and cyclooxygenase-2 (COX-2) expressions and increase the expression of cytochrome P4502E1 (CYP2E1) in CCl₄-treated mice. Dehydroeburicoic acid has analgesic activity.

Dehydroeburicoic acid has antidiabetic and antihyperlipidemic properties in [5]

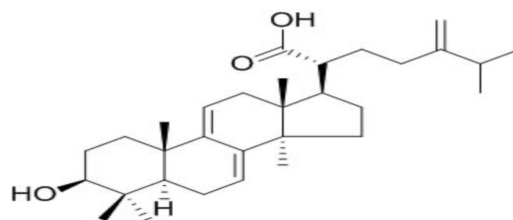
