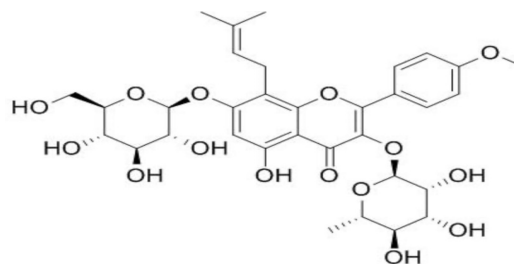

Icariin, the main active compound of *Epimedium pubescens*, exerts its potent osteogenic effect through induction of Runx2 expression, production of BMP-4 and activation of BMP [1,2]

signaling, it has antiosteoporotic activity in ovariectomized rats.

Icariin pretreatment can reduce the nucleus transportation and constant level of NF- $\kappa$ B p65 in the RAW 264.7 macrophage cells, the protective effects of icariin were reversed by a PI3K/Akt inhibitor (wortmannin), suggests that the activation of the PI3K/Akt pathway and the inhibition of NF- $\kappa$ B are involved in the protective effects of icariin on LPS-induced

Icariin is a safe anabolic agent of chondrocytes, it may exert its protective effects through inhibition of nitric oxide and MMP synthesis, and may then reduce the extracellular matrix

Pretreatment with icariin can decrease neurological deficit score, diminish the infarct volume, and reduce the protein levels of IL-1 $\beta$  and TGF- $\beta$ 1, it suppresses I $\kappa$ B- $\alpha$  degradation and NF- $\kappa$ B activation induced by I/R, it also up-regulates PPAR $\alpha$  and PPAR $\gamma$  protein levels, suggests that icariin has neuroprotective effect on ischemic stroke in rats through inhibition of inflammatory responses mediated by NF- $\kappa$ B and PPAR $\alpha$  and

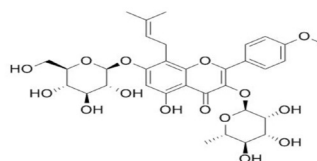
