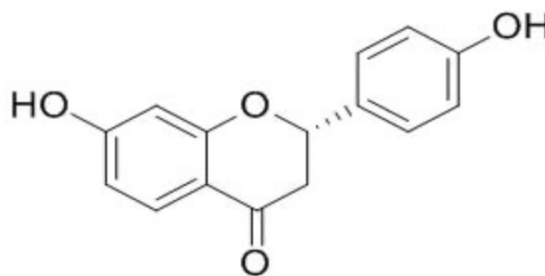

Liquiritigenin dose dependently alleviated mechanical, thermal and cold hyperalgesia, and daily repeated treatment with liquiritigenin did not demonstrate significant antinociceptive tolerance in the measures of hyperalgesia, and did not significantly affect motor performance, suggests that liquiritigenin may be potentially useful novel treatments for

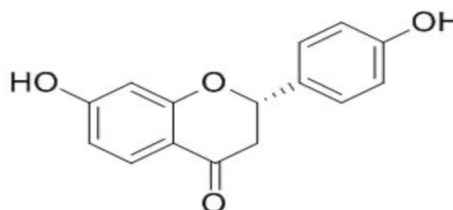
