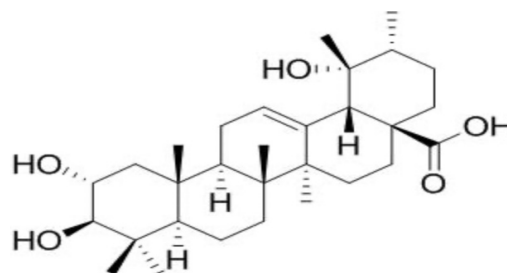

Tormentic acid has anti-inflammatory activity, it potently inhibits the production of nitric oxide (NO) in RAW 264.7 cells, also suppresses the LPS-stimulated degradation and phosphorylation of inhibitor of kappa B- α (I κ B- α), suggests that the anti-inflammatory activity of TA is associated with the down-regulation of iNOS, COX-2, and TNF- α through

[2] Tormentic acid has anticancer, anti-atherogenic properties and minimal toxicity in vivo, it the negative regulation of the NF- κ B pathway in RAW 264.7 cells.

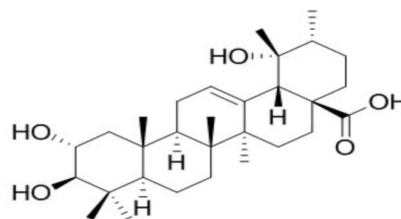
