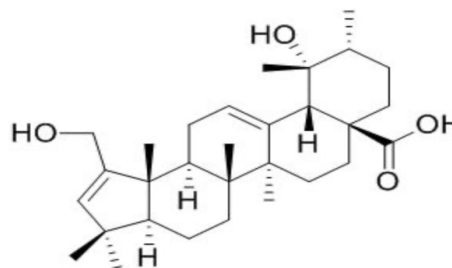

Hyptadienic acid exhibits moderate cytotoxicity against HepG2 cells. Hyptadienic acid shows a marked anti-inflammatory effect, it also exhibits strong antitumor-promoting activity in an in vivo two-stage carcinogenesis test of mouse tumor by [2] using 7,12-dimethylbenz(a)anthracene (DMBA) as an initiator and TPA as a promoter.

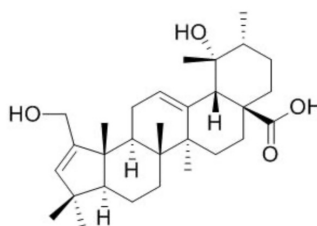
