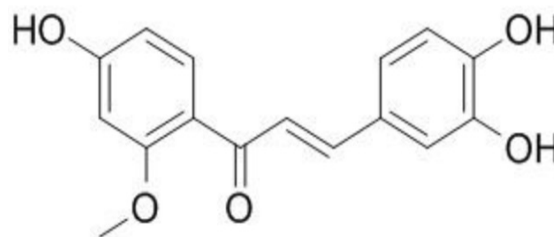

BIOLOGICAL ACTIVITY OR INHIBITORS

Sappanchalcone, a flavonoid extracted from *Caesalpinia sappan*, exhibits cytoprotective activity, it suppresses oral cancer cell growth and induces apoptosis through the activation of p53-dependent mitochondrial, p38, ERK, JNK, and NF- κ B signaling, thus, it has potential as a chemotherapeutic agent for oral cancer.[1]

Sappanchalcone has anti-inflammatory effects, it reduces clinical arthritis, inflammatory edema in paws and maintains bone mineral density and trabecular structure in collagen-induced arthritis (CIA) mice, it could be used as an anti-inflammatory and bone-protective agent during the treatment of rheumatoid arthritis.[2]

Sappanchalcone possesses the most potent effect against allergic reaction in basophilic leukemic (RBL-2H3) cells with an inhibitory concentration (IC₅₀) value of 7.6 μ M, it may have anti-allergic activity.[3]

Sappanchalcone shows xanthine oxidase inhibitory activity, is a inhibitor.[4]

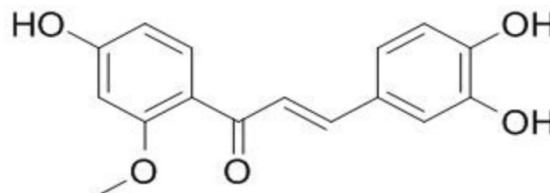
