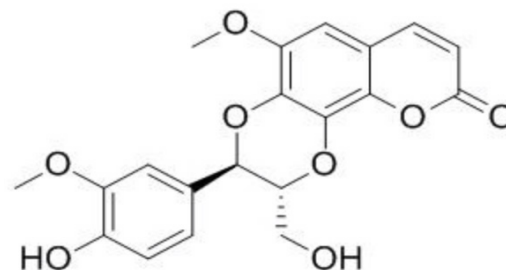

BIOLOGICAL ACTIVITY OR INHIBITORS

Cleomiscosin-A and brusatol from *Brucea javanica* are antitumor agents, have antileukemic principles.[1] Cleomiscosin A and cleomiscosin C have antioxidant activity, they protect against the oxidative modification of apoB-100 induced by either Cu²⁺ or HOCl (1, IC₅₀s of 13.4 and 8.1 microM, respectively; 2, IC₅₀s of 23.6 and 3.9 microM, respectively), suggests that they could be beneficial in preventing LDL oxidation in atherosclerotic lesions.[2] Cleomiscosin A methyl ether derivatives have anti-inflammatory activity. [3] Cleomiscosin A shows inhibitory activity to TNF- α secretion of the mouse peritoneal macrophages.[4] The mixture of three compounds (cleomiscosin A, B and C) is showing the significant protective effects against CCl₄-induced hepatotoxicity in small animals and also coumarinolignoids are well tolerated by small animals in acute oral study.[5]

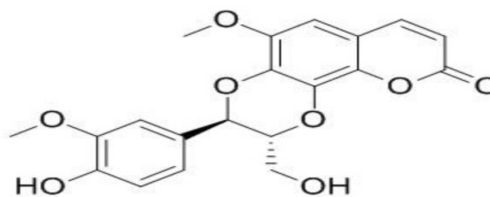
