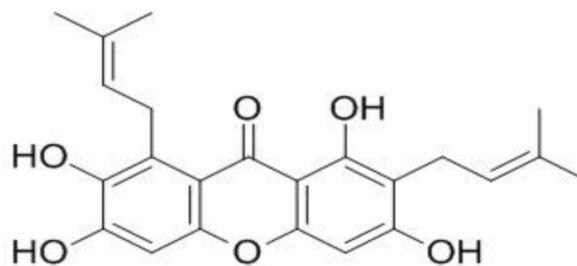

BIOLOGICAL ACTIVITY OR INHIBITORS

gamma-Mangostin can competitively inhibit the activities of both COX-1 and -2, it has a potent inhibitory activity of prostaglandin E2 (PGE2) release induced by A23187, a Ca²⁺ ionophore.[1]

γ-Mangostin can directly inhibit inhibitor κB (IκB) kinase (IKK) activity and thereby prevents COX-2 gene transcription, an NF-κB target gene, probably to decrease the inflammatory agent-stimulated prostaglandin E2 (PGE2) production in vivo, and is a new useful lead compound for anti-inflammatory drug development.[2]

γ-Mangostin shows anticancer activity and induces apoptosis in HT29 colorectal adenocarcinoma cells, suggests that γ-mangostin can serve as a micronutrient for colon cancer prevention and is a potential lead compound for the development of anti-colon cancer agents. [3]

Combinations of γ-mangostin with penicillin G can generate synergistic effect against *L. interrogans* serovars Bataviae, Autumnalis and Javanica (FIC=0.52, 0.50, and 0.04, respectively) and no interaction against *L. biflexa* serovar Patoc (FIC =0.75).[4] gamma-Mangostin is a novel competitive antagonist, free from a nitrogen atom, for the 5-HT_{2A} receptors in vascular smooth muscles and platelets.[5]

gamma-Mangostin exhibits analgesic effects and the ability to scavenge reactive oxygen species.[6]

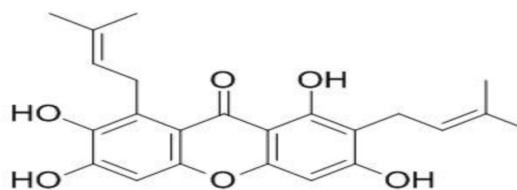
