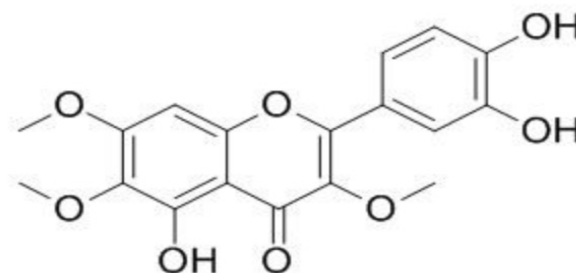

### BIOLOGICAL ACTIVITY OR INHIBITORS

Chrysofenol D can suppress lipopolysaccharide (LPS)-induced release of IL-1 beta, IL-6 and MCP-1, inhibit cell migration, and reduce LPS-induced I $\kappa$ B and c-JUN phosphorylation in Raw264.7 cells, thus, it can inhibit inflammation in vitro and in vivo.[1]

Chrysofenol D, artemetin, and chrysofenetin have IC50 values at  $2.4 - 6.5 \times 10^{-5}$ M against *P. falciparum* in vitro.[2]

Chrysofenol D exerts its anti-proliferative effect on tsFT210 cells through inhibiting cell cycle and inducing apoptosis, it may as a new cell cycle inhibitor. [3]

Chrysofenol-D displays antibacterial and antifungal activities.[4]

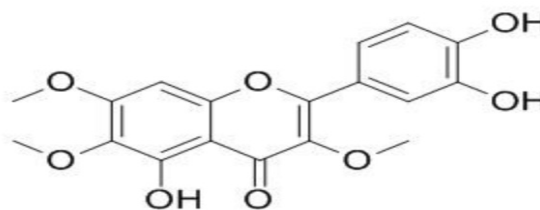
