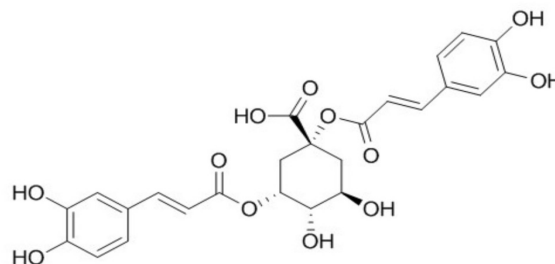

### BIOLOGICAL ACTIVITY OR INHIBITORS

1,5-Dicaffeoylquinic acid (1,5-DQA), a caffeoylquinic acid derivative isolated from *Aster scaber*, has neuroprotective effects, can prevent A $\beta$ (42)-induced neurotoxicity through the activation of PI3K/Akt followed by the stimulation of Trk A, then the inhibition of GSK3 $\beta$  as well as the modulation of Bcl-2/Bax.[1]

1,5-Dicaffeoylquinic acid has antioxidant activity, and is stronger than that of ascorbic acid.[2]

1,5-Dicaffeoylquinic Acid has protective effects against MPP<sup>+</sup> induces neurotoxicity of PC12 Cells, it (50  $\mu$ mol/L) pretreatment can inhibit the MPP<sup>+</sup>-induced up-regulation of the expression of  $\alpha$ -synuclein mRNA and protein.[3]

1, 5-Dicaffeoylquinic acid can mediate glutathione synthesis through activation of Nrf2 protects against OGD/reperfusion-induced oxidative stress in astrocytes.[4]

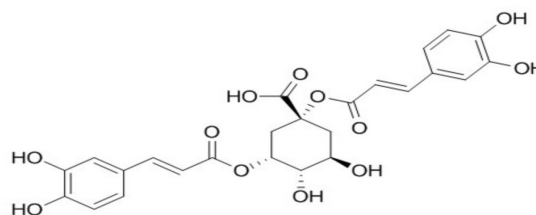
