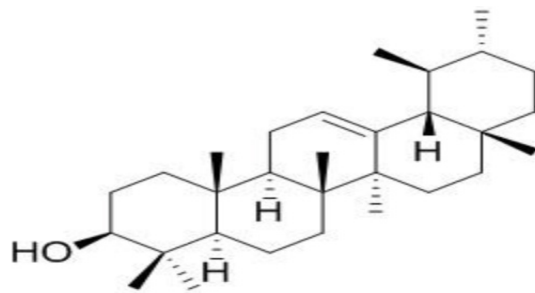

BIOLOGICAL ACTIVITY OR INHIBITORS

The mixture of triterpene alpha-amyrin and beta-amyrin can produce consistent peripheral, spinal, and supraspinal antinociception in rodents, especially when assessed in inflammatory models of pain, the mechanisms seem to involve the inhibition of protein kinase A- and protein kinase C-sensitive pathways.[1]

alpha-Amyrin can dose-dependently prevent the increase of the proinflammatory cytokine interleukin-1beta levels in response to topical application of 12-O-tetradecanoylphorbol- acetate (TPA), the efficacy of alpha-amyrin is very similar to that produced by dexamethasone; thus, alpha-amyrin is a good candidate to develop a skin permeable antiinflammatory drug.[2]

alpha-Amyrin can attenuate high-fructose diet (HFD)-induced metabolic syndrome in rats, it can prevent a significant increase in systolic blood pressure, plasma glucose, total cholesterol, and plasma triglycerides and a significant decrease in HDL-C, preserve the hepatic mRNA and protein levels of peroxisome proliferator-activated receptor alpha (PPAR- α). 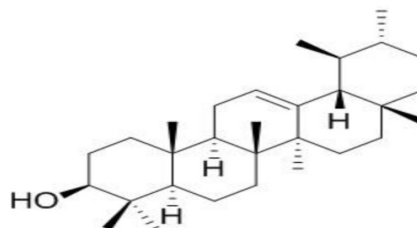
