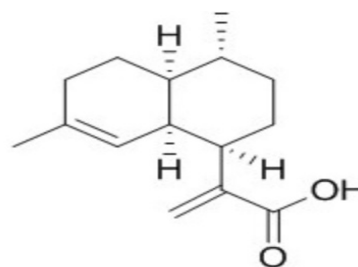

### BIOLOGICAL ACTIVITY OR INHIBITORS

Artemisinic acid, is the immediate precursor of the semi-synthesis artemisinin, could be a cost-effective, environmentally friendly, high-quality and reliable source of artemisinin;and artemisinin is highly effective against multi-drug-resistant Plasmodium spp. [1]

Artemisinic acid was studied as a novel elicitor to enhance the yield of terpenoid indole alkaloids, artemisinic acid can up-regulate the transcriptions of tryptophan decarboxylase, geraniol10-hydroxylase,tabersonine 16-hydroxylase and deacetoxyvindoline 4-hydroxylase.[2]

Artemisinic acid is a regulator of adipocyte differentiation and C/EBP  $\delta$  expression, it can inhibit adipogenic differentiation of hAMSCs by occurs primarily through reduced expression of  $\delta$ , which is mediated by the inhibition of and suggest that artemisinic acid may be used as a complementary treatment option for associated with metabolic syndrome.[3]

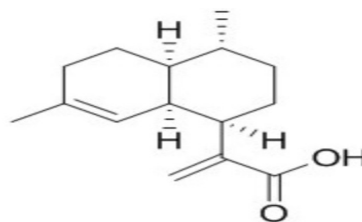
