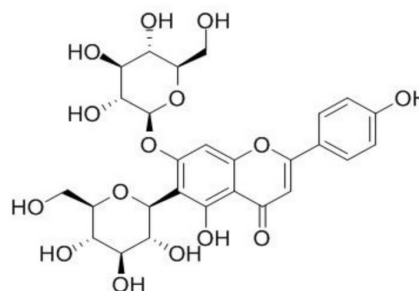

### BIOLOGICAL ACTIVITY OR INHIBITORS

---

Saponarin has antioxidant activity, is characterized as  $\alpha$ -glucosidase inhibitor present in *Tinospora cordifolia*, it also has hypoglycemic activity.[1]

Saponarin has protective effect against cocaine-induced oxidative stress and hepatotoxicity, it also shows in vitro and in vivo hepatoprotective and antioxidant activity against CCl<sub>4</sub>-induced liver damage.[2,3]

Saponarin exerts anti-inflammatory effects in LPS-induced RAW 264.7 macrophages via inhibition of NF- $\kappa$ B, ERK and p38 signaling, thus, it may be a promising natural anti-inflammatory agent. [4]

Saponarin exerts slight antihypertensive activity in non-diabetic spontaneously hypertensive rats (SHR), however, such effect is not observed in streptozotocin-induced diabetic SHR (SHR-D), indicates that diabetes and hypertension in combination are more difficult to be modulated by saponarin.[5]

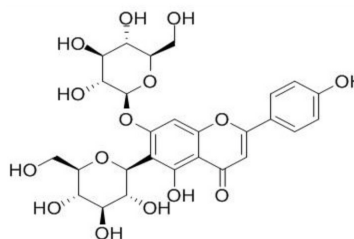
