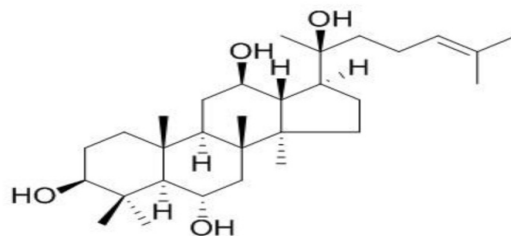

BIOLOGICAL ACTIVITY OR INHIBITORS

20(S)-Protopanaxatriol (PPT), one of the ginsenoside metabolites, it can increase peroxisome proliferator-activated receptor gamma (PPARgamma)-transactivation activity dose-dependently with similar activity as troglitazone, a well-known PPARgamma agonist; it can enhance adipogenesis by increasing the expression of PPARgamma target genes such as aP2, LPL and PEPCCK, it significantly increases expression of glucose transporter 4 (GLUT4); indicates that PPT can be developed as a PPARgamma agonist for the improvement of insulin resistance associated with diabetes.[1]

20(S)-protopanaxatriol has anti-allergic effects, it reduces the release of inflammatory mediators via inhibiting multiple cellular signaling pathways comprising the Ca²⁺ influx, protein kinase C, and phospholipase A2 (PLA2), which are propagated by Syk activation upon allergic stimulation of mast cells.[2]

20(S)-Protopanaxatriol inhibits inducible nitric oxide synthase and cyclooxygenase-2 expressions through inactivation of nuclear factor-κB in RAW 264.7 macrophages stimulated with lipopolysaccharide, it may be possible to develop PPT as a useful agent for chemoprevention of cancer or inflammatory diseases.[3]

Mobile phase: 10% acetonitrile aqueous solution containing 5% acetic acid- 80% acetonitrile aqueous solution water, gradient elution;

Flow rate of gas : 1.8L/min;

Carrier gas: N₂.

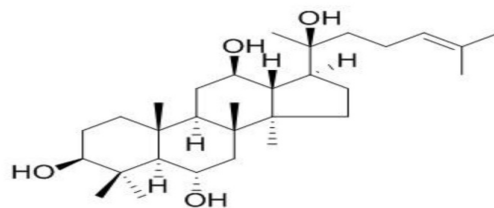
