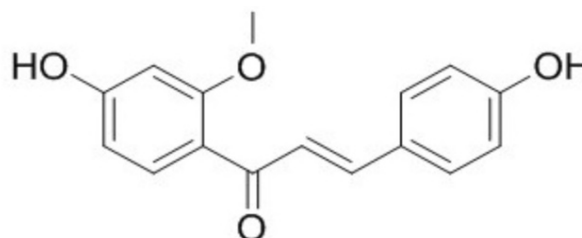

3-Deoxysappanchalcone inhibits tumor necrosis factor- α -induced matrix metalloproteinase-9 expression in human keratinocytes through activated protein-1 inhibition and nuclear factor-kappa B DNA binding activity. [1]

3-Deoxysappanchalcone has anti-influenza virus activity, the mechanism is involved anti-apoptosis and anti-inflammation activities in vitro, it could be a promising drug candidate for influenza treatment.[2]

3-Deoxysappanchalcone may be an effective HO-1 inducer at the translational level that has anti-inflammatory effects, and a valuable compound for modulating inflammatory conditions. [3]

3-Deoxysappanchalcone has potent effect against allergic reaction in RBL-2H3 cells with an inhibitory concentration (IC50) value of 15.3 microM.[4]

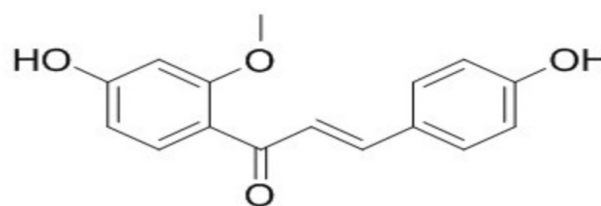
