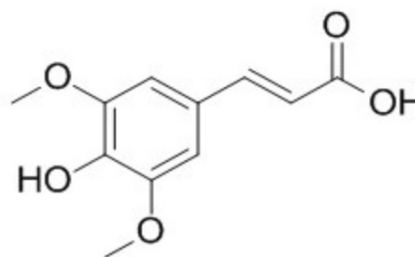

### BIOLOGICAL ACTIVITY OR INHIBITORS

Sinapic acid exerts anti-inflammatory effects via the suppressions of the expressions of iNOS, COX-2, TNF-alpha, and IL-1beta via NF-kappaB inactivation.[1]

Sinapic acid, sinapine and different tocopherols are compared as antioxidants for inhibition of the formation of lipid oxidation products in purified rapeseed oils.[2]

Sinapic acid is a prominent anxiolytic agent, and that its anxiolytic-like effects are mediated via GABA(A) receptors and potentiating Cl(-) currents. [3]

Sinapic acid is a very important moiety in the pharmacological activities of tenuifoliside B and 3,6'-disinapoylsucrose, and is a candidate for a cerebral protective and cognition-improving medicine.[4]

Sinapic acid is a phenylpropanoid compound with anti-inflammatory and neuroprotective activities, it can ameliorate A $\beta$  1-42 protein-related pathology including neuronal cell death and cognitive dysfunction via its anti-oxidative and anti-inflammatory activities, and may be an efficacious treatment for Alzheimer's disease (AD).[5]

Sinapic acid has protective effects on lysosomal dysfunction in isoproterenol induced myocardial infarcted rats. [6]

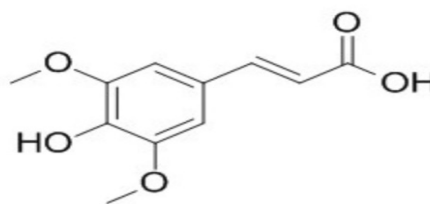
