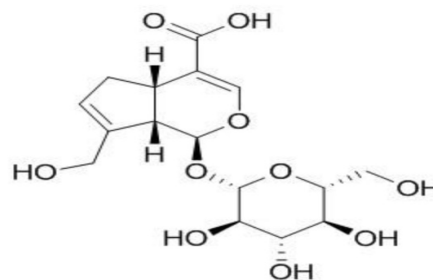

### BIOLOGICAL ACTIVITY OR INHIBITORS

Geniposidic acid, one of the main active ingredients in *Gardenia jasminoides* J. Ellis (Rubiaceae), has anti-atherosclerotic effects, can protect vascular endothelium and reverse plaque formation in an atherosclerotic model. [1]

Geniposidic acid and geniposide have antitumor effects, play a role in an effective anticancer product with the ability to decrease undesirable radiation damage to the hematologic tissue after high dose irradiation. [2]

Geniposidic acid can protect against D-galactosamine and lipopolysaccharide-induced hepatic failure in mice. [3]

Geniposidic acid protects against anti-induced hepatotoxicity and acute intrahepatic cholestasis, due to Fxr-mediated regulation of Bsep and Mrp2. [4]

Geniposidic acid has effects on the expression of MRP2 and BSEP in BRL-3A cells after FXR gene silencing mediated by si RNA. [5]

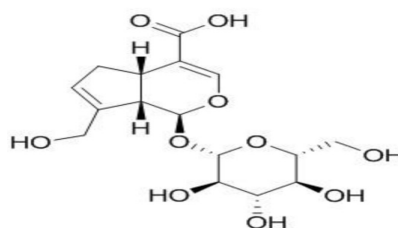
