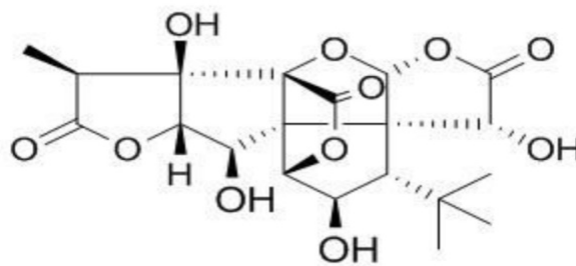

BIOLOGICAL ACTIVITY OR INHIBITORS

Ginkgolide C (GC) from Ginkgo biloba leaves, is a potent inhibitor of collagen-stimulated platelet aggregation, it may increase intracellular cAMP and cGMP production and MMP-9 activity, inhibit intracellular Ca(2+) mobilization and TXA(2) production, thereby leading to inhibition of platelet aggregation, it may be a suitable tool for a negative regulator during platelet activation. [1]

Ginkgolide C has anti-adipogenic effect, it is an effective flavone for increasing lipolysis and inhibiting adipogenesis in adipocytes through the activated AMPK pathway.[2] Ginkgolide C can increase LVP significantly, enhances the myocardial systolic and diastolic function of rats, but has no significant effect on HR while it shows inotropic activity.[3]

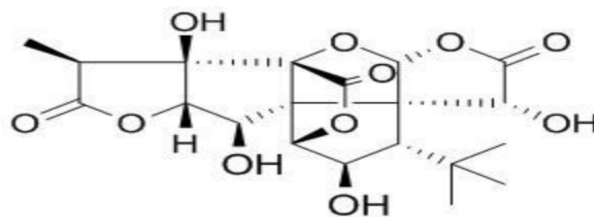
