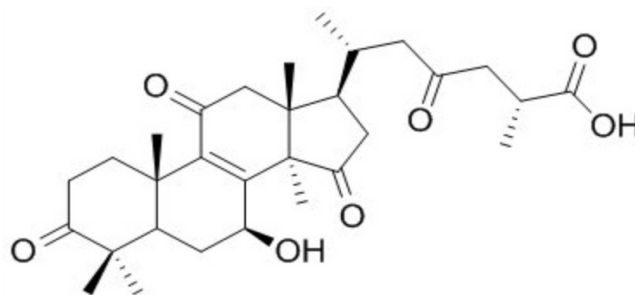

BIOLOGICAL ACTIVITY OR INHIBITORS

Ganoderic acid C1(GAC1), isolated from the ganoderma mushroom, has cytotoxicity in vitro against Lewis lung carcinoma (LLC), T-47D, Sarcoma 180, and Meth-A tumor cell lines. [1]

Ganoderic acid C1 significantly reduces TNF- α production by murine macrophages (RAW 264.7 cells) and peripheral blood mononuclear cells (PBMCs) from asthma patients; inhibition is associated with down-regulation of NF- κ B expression, and partial suppression of MAPK and AP-1 signaling pathways; suggests that GAC1 may have potential for treating TNF- α mediated inflammation in asthma and other inflammatory diseases. [2] Ganoderic acid C1 is moderately active inhibitors against HIV-1 PR with a 50% inhibitory concentration of 0.17–0.23mM. [3]

Ganoderic acid C1 can inhibit TNF- α production in RW-stimulated RAW264.7 cells in association with suppression of phosphorylated I κ B and increases HDAC2 expression, GAC1 may be a valuable option for treating neutrophil-predominant asthma. [4]

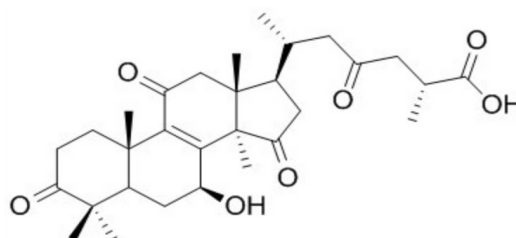
