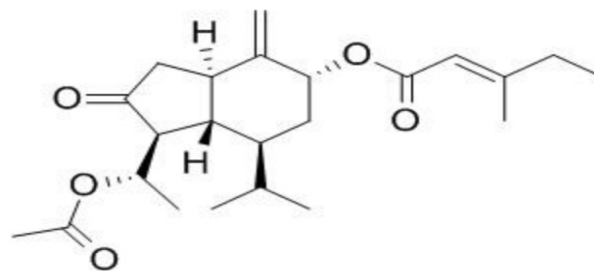

BIOLOGICAL ACTIVITY OR INHIBITORS

Tussilagone (TUS) is a potent cardiovascular and respiratory stimulant.[1]

Tussilagone may be an effective heme oxygenase-1 (HO-1) inducer that has anti-inflammatory effects, and a valuable compound for modulating inflammatory conditions.[2]

Tussilagone may have therapeutic potential in the treatment of neuro-inflammatory diseases through the inhibition of overproduction of NO and PGE(2). [3]

Tussilagone, an inhibitor on β -catenin dependent Wnt pathway, it suppresses the β -catenin activity and also decreases the expression of cyclin D1 and c-myc, representative target genes of the Wnt/ β -catenin signaling pathway, and consequently inhibits the proliferation of colon cancer cells, TSL may be a potential chemotherapeutic agent for the prevention and treatment of human colon cancer.[4]

Tussilagone has a strong antiallergic effect.[5]

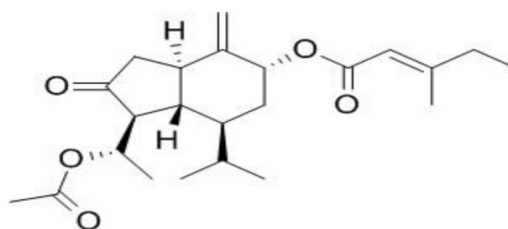
