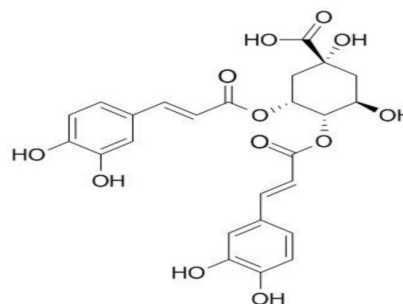

BIOLOGICAL ACTIVITY OR INHIBITORS

Isochlorogenic acid C(ICAC) possesses potent hepatoprotective and anti-HBV effects; the anti-apoptotic and anti-injury effects of ICAC could be achieved by its anti-oxidative properties and interfering the caspase-3 and transformed growth factor beta-1(TGFbeta-1) expressions; the anti-HBV target of ICAC may mainly be at the downstream links of HBV replication process and is probably associated with blocking translation step; HO-1 induction may contribute to anti-hepatitis B effect of ICAC.[1]

Isochlorogenic acid C has antiinflammatory activities, it can decrease LPS-induced NO production in RAW264.7 cell, and inhibit TPA-induced ear edema. [2]

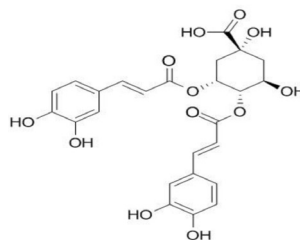
