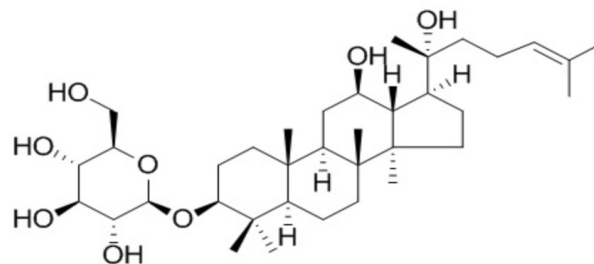

BIOLOGICAL ACTIVITY OR INHIBITORS

20(R)-Ginsenoside Rh2 is isolated from Chinese traditional ginsengs with main antitumor effects, it has the effect of promoting A549 cell apoptosis.[1]

20(R)-ginsenoside Rh2 possesses matrix metalloproteinase inhibitory, anti-inflammatory and antioxidative activity, it can suppress NO, PGE2, ROS and pro-matrix metalloproteinase-9 (pro-MMP-9) levels that are enhanced in the LPS-stimulated murine RAW264.7 macrophage cells, it also exhibits inhibitory effects on the level of ROS and the activity of MMP-9 and -2 in human HaCat keratinocyte cells without stimulant exposure.[2]

20(R)-ginsenoside Rh2 has antiviral activity against murine gamma-herpesvirus. [3] Ginsenoside 20(R)-Rh2, not 20(S) shows selective osteoclastogenesis inhibitory activity without any cytotoxicity up to 100 μ M, implies that the stereochemistry of the hydroxyl group at C-20 may play an important role in selective osteoclastogenesis inhibitory activity.[4]

Ginsenoside Rh2 possesses skin anti-photoaging effects, it can suppress UV-B-induced ROS production in HaCat cells.[5]

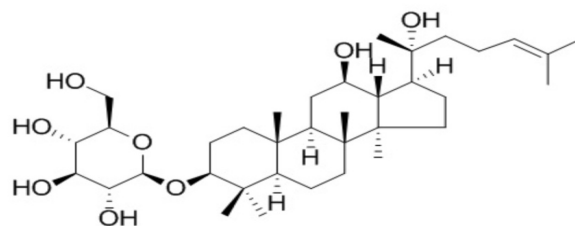
