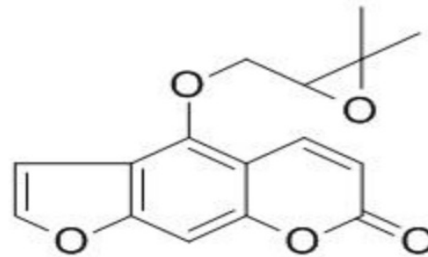

### BIOLOGICAL ACTIVITY OR INHIBITORS

---

Oxypeucedanin is a major coumarin aglycone that can be extracted from *Ostericum koreanum*, coumarin aglycones have demonstrated various pharmacological effects, including anti-proliferation, anti-inflammation, and anti-pain; based on transcriptional alteration and complicated modulation of MAPK signaling, might be underlying mechanisms responsible for the various pharmacological effects of oxypeucedanin.[1] Oxypeucedanin has a novel anticancer effect, mediated via induction of G2-M cell cycle arrest and apoptosis in human prostate carcinoma DU145 cells.[2]

Oxypeucedanin is a kind of open-channel blocker of the hKv1.5 channel and it prolongs the APD, therefore, it is an excellent candidate as an antiarrhythmic drug for atrial fibrillation.[3]

Oxypeucedanin and osthole have protective effects on doxorubicin -induced apoptosis in PC12 cells.[4]

Oxypeucedanin has hypotensive effects , the effect is related to dilate blood vessels.[5] Oxypeucedanin has anti-diarrheal and anti-inflammatory effects .[6]

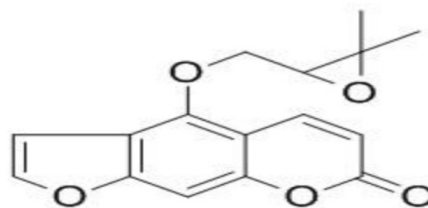
