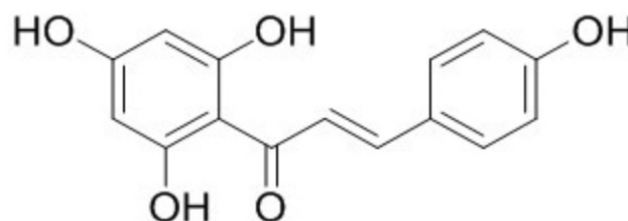

BIOLOGICAL ACTIVITY OR INHIBITORS

Naringenin chalcone exhibits anti-inflammatory properties by inhibiting the production of proinflammatory cytokines in the interaction between adipocytes and macrophages, it may be useful for ameliorating the inflammatory changes in obese adipose tissue.[1]

Naringenin chalcone shows the strongest inhibitory effect of the polyphenols of the tomato skin extract, it inhibits histamine release with an IC50 value of 68 microg/ml, indicates that a tomato skin extract could inhibit allergic reactions; it is a potent tomato flavonoid that improves adipocyte metabolic functions and exerts insulin-sensitizing effects by activating an adiponectin-related pathway. Naringenin chalcone suppresses asthmatic symptoms by inhibiting Th2 cytokine production from CD4 T cells, thus, it may be a useful supplement for the suppression of allergic symptoms in humans.[4]

Naringenin chalcone has anti-cancer effect, which is mediated via the induction of autophagy, apoptosis and activation of PI3K/Akt signalling pathway.[5]

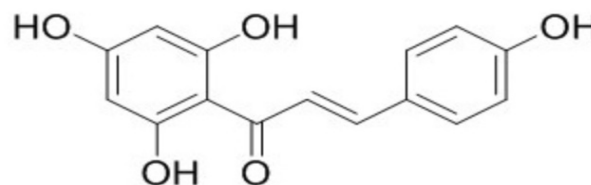
