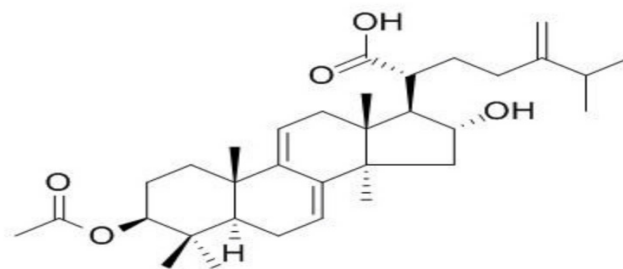

BIOLOGICAL ACTIVITY OR INHIBITORS

Dehydropachymic acid exhibits moderate cytotoxicities, with IC50 values of 20.5 microM against a human colon carcinoma cell line; it not only shows inhibitory activities as potent as etoposide used as a positive control on DNA topoisomerase II (36.2% inhibition at a concentration of 20 microM), but also inhibition of DNA topoisomerase I (60.7 inhibition at a concentration of 100 microM).[1]

Dehydroeburiconic acid shows inhibitory activity against 12-O-tetradecanoylphorbol-13 -acetate (TPA)-induced ear inflammatory oedema.[2]

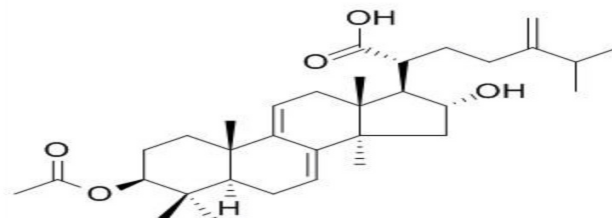
