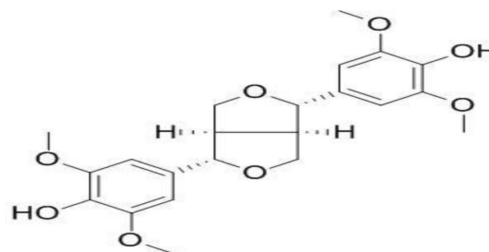

BIOLOGICAL ACTIVITY OR INHIBITORS

(+)-Syringaresinol from unripe Japanese apricot has inhibition of Helicobacter pylori motility at a concentration of 500 microg/ml and the IC50 value was 50 microg/ml. [1]

(-)-Syringaresinol and triclin show inhibitory effects on the P-glycoprotein in adriamycin- resistant human breast cancer cells, MCF-7/ADR.[2]

(-)-Syringaresinol can potently inhibit the proliferation of human promyelocytic HL-60 cells through G(1) arrest and induction of apoptosis, suggests that (-)-syringaresinol may be a potential chemotherapeutic agent for the treatment of cancer.[3]

Syringaresinol induces vasorelaxation by enhancing NO production in endothelial cells via two distinct mechanisms, phosphatidylinositol 3-kinase/Akt- and (PLC)/Ca²⁺/CaMKK β - dependent eNOS phosphorylation and Ca(2+)-dependent eNOS dimerization. [4]

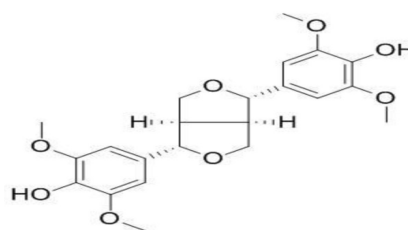
