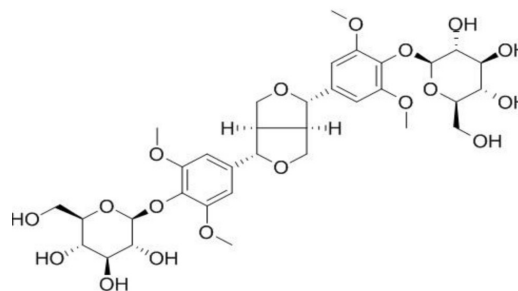

BIOLOGICAL ACTIVITY OR INHIBITORS

Syringaresinol di-O-glucoside, isolated from *Eleutherococcus senticosus* and syringin, can protect the animals from the stress-induced decreases in sex behaviours and in rectal temperature, the stress-induced failure of retrieval of memory, and the stress-induced enlargement of adrenal gland.[1]

(+)-Syringaresinol-di-O-b-D-glucoside can modulate the inflammatory process involved in arthritis by suppressing various gene expression through inhibiting AP-1 and/or NF-kappaB activities.[2]

Syringaresinol di-o-beta-D-glucoside and chlorogenic acid show a significantly inhibitory effect on gastric ulcer, suggests that the protective effect of the stem bark of *A. senticosus* on gastric ulcer may be partially due to those of chlorogenic acid and syringaresinol di-o-beta-D-glucoside.
