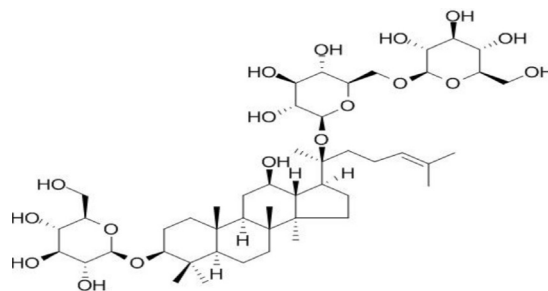

### BIOLOGICAL ACTIVITY OR INHIBITORS

Gypenoside XVII (GP-17) is a novel phytoestrogen isolated from *Gynostemma pentaphyllum* or *Panax notoginseng*, GP-17 confers protection against A $\beta$ 25-35-induced neurotoxicity through estrogen receptor-dependent activation of PI3K/Akt pathways, inactivation of GSK-3 $\beta$  and activation of Nrf2/ARE/HO-1 pathways, this finding might provide novel insights into understanding the mechanism for neuroprotective effects of phytoestrogens or gypenosides.[1]

Gypenoside XVII enhances lysosome biogenesis and autophagy flux and accelerates autophagic clearance of Amyloid- $\beta$  through transcription factor EB (TFEB) activation, it ameliorates amyloid- $\beta$ (A $\beta$ )25-35-induced apoptosis in PC12 cells by regulating autophagy, demonstrates that GP-17 conferred protective effects to the cellular and rodent models of Alzheimer's disease by activating TFEB.[2]

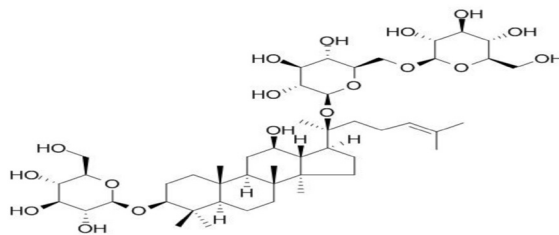
