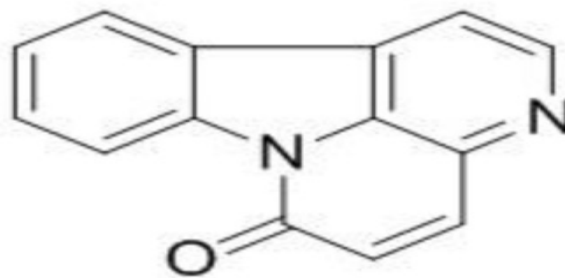

Canthin-6-One alkaloids has cytotoxicities by ailanthus altissima plant cell cultures.[1]

Two canthin-6-one alkaloids have antibacterial activity from allium neapolitanum.[2]

Canthin-6-one of Simaba ferruginea A. St-Hil. has anti-ulcer activity in animal models.[3]

Canthin-6-one has antiproliferative effects, possibly by interfering with the G2/M transition, the proapoptotic effects may result from this disturbance of the cell cycle.[4]

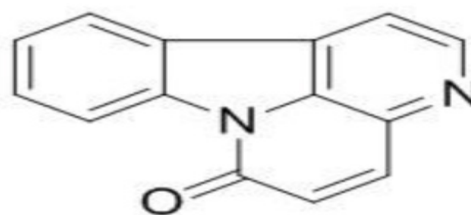
