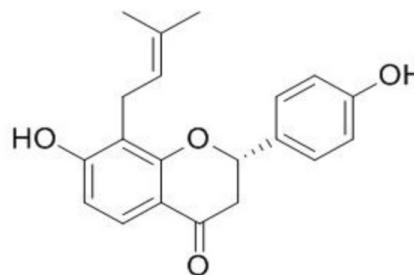

BIOLOGICAL ACTIVITY OR INHIBITORS

Isobavachin can facilitate mouse embryonic stem cells differentiating into neuronal cells, the mechanism involved protein prenylation and, subsequently, phos-ERK activation and the phos-p38 off pathway.[1]

Isobavachin possesses estrogen-like activity in MCF-7/BOS cells, it can significantly stimulate the proliferation of MCF-7/BOS cells in a dose-dependent manner.[2]

Isobavachin has cytotoxic effects on H4IIE hepatoma and metabolically poorly active C6 glioma cells.[3]

Isobavachin and bavachin can stimulate osteoblasts proliferation and differentiation.[4]

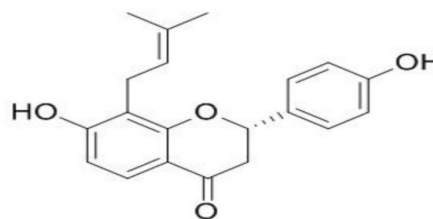
