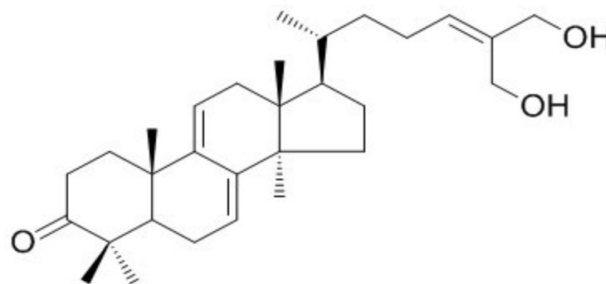

### BIOLOGICAL ACTIVITY OR INHIBITORS

---

Ganoderiol F( GoF) , a tetracyclic triterpene, was isolated from *Ganoderma amboinense* and found to induce senescence of cancer cell lines, it induces growth arrest of cancer cell lines HepG2, Huh7 and K562; activation of the mitogen-activated protein kinase ERK and up-regulation of cyclin-dependent kinase inhibitor p16 were found in early stages of GoF treatment and were presumed to cause cell-cycle arrest and trigger premature senescence of HepG2 cells; suggests that the growth-arrest and senescence induction capability on cancer cells suggest anticancer potential of GoF.[1]

Ganoderiol-F could be developed further as both anti-HIV and antimalaria, the affinity of ganoderiol-F is higher towards HIV-1 protease (binding energy= -11.40kcal/mol and  $K_i$ = 4.68nM) than to plasmepsin I (binding energy= -9.96 kcal/mol and  $K_i$ = 50.94 nM), meanwhile pepstatin-A has better affinity towards HIV-1 protease (binding energy= -4.52 kcal/mol and  $K_i$ = 496.13 uM) than to plasmepsin I (binding energy= -3.07 kcal/mol and  $K_i$ = 5.98 mM).[2]

Ganoderiol F shows binding activity to androgen receptor and inhibits LNCaP cell proliferation.[3]

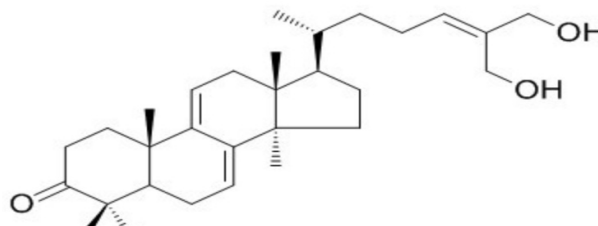
